### Township of Mantua Minutes Meeting June 20, 2016 Mantua Township Municipal Building 6:00 P.M.

On the above date the Township Committee of the Township of Mantua held its Regular Meeting in the Mantua Township Municipal Building, 401 Main Street, Mantua, New Jersey 08051.

Mayor Scirrotto called the meeting to order. The time was 6:00 p.m. Mayor Scirrotto asked everyone to rise for the Flag Salute and remain standing to observe a moment of silence.

Mayor Scirrotto delivered the Sunshine Notice as required by the New Jersey Open Public Meetings Act.

Mayor Scirrotto called on Township Deputy Clerk Pamela LeVine to call roll. Present were Deputy Mayor Robert Zimmerman, Mr. Michael Silvanio, Mr. Legge - Absent, Mayor Pete Scirrotto, Mrs. Jennica Bileci, Township Administrator, James Pierson Esq. Chief Sawyer

## Approval of Minutes: June 20, 2016

Deputy Mayor Zimmerman made a motion to close to the public, 2<sup>nd</sup> by Committeeman Silvanio, Committeewoman Lukens Abstained.

## **<u>Public Participation</u>:**

<u>Bruce Cocchi – 47 Monroe Ave</u> – Asked the Committee what can be done to correct the situation at Route 45 and Mount Royal Road. Mayor Scirrotto advised that the Assemblywoman that is here with us tonight would be looking into it. The County, Township as well as the Chief of Police have all met with the DOT to have this corrected. The state is still considering what can be done. In addition, he inquired as to what can be done about the people cutting through the Wawa at that same intersection. It's a danger to the residents that live around there. Lastly, he'd like to know what can be done to stop the drivers that are cutting through is development. Chief Sawyer advised that they will have a better presence out there and will put the speed signs up to get some sort of the amount of traffic that is going through there.

<u>Dominic Scardino – 222 Burlington Avenue</u> – Inquired about when and if Fairview Drive would be getting paved. Mr. Scardino advised that he drives this road in order to go back to his street where he lives. This road has been a problem for several years and nothing seems to be getting done. Administrator Bileci advised that they are aware that this street is a problem, however it is very costly to repave this road as the curbing is quite expensive. Administrator Bileci also advised that they will review the road and inquire if we can include some patching repairs in effort to address the concerns.

Ken Defay – 456 Pitman Road – Mr. Defay inquired about the boned matters that were on this current agent. Administrator Bileci advised that the down payment was part of the budget and that when one bond comes off another one gets added thus allowing the township to get the necessary funding that they are requiring to do certain improvements. Mr. Defay inquired about why the Township needs a new recycling truck at all. Administrator Bileci advised that they are in need of one in order to pick up during the bulk week items such as white goods cardboard amongst other things. In addition, Mr. Defay asked why Deptford Township isn't taking on any responsibility for the new Tall Pines area. Mayor Scirrotto advised that that was a decision that they made. This is the first State park and Mantua Township had something to do with this happening. There were several parties involved, multiple townships, the County as well as the State including the Friends of Maple Ridge who raised \$140,000. In addition the Mayor advised that there will be less homes in the area and more open space.

Mayor Scirrotto also advised Mr. Defay that the super box has been emptied and will be removed sometime this week.

Assemblywoman Patrician Egan-Jones thanked everyone for allowing her to come to the meeting and advised all that she was here to look into the problem at Route 45 and Mount Royal Road. She will do what she can to have the state relook at this area as well as do whatever it takes to have them reconsider funding of Mantua road programs.
