### **Portable Storage Container Permit**

**Disclaimer:** A portable storage structure falls under the umbrella of Construction Trailers, Portable Storage Containers, and Temporary Storage Structures. The POD application form must be filled out **completely** for processing.

1. Application must be submitted with a sketch detailing the distance of the proposed container from other buildings, fire hydrants, and other utilities on site. Containers may not be placed in the street, public right of way or unimproved surfaces in the front yard.
2. Permits shall be issued for a period of 30 days and **may not exceed 30 days on the site from time of delivery to removal**. Extensions must be applied for prior to when the initial 30 day zoning approval period is over (additional fees applied).
3. A portable storage container may not exceed 10 feet in height, 10 feet in width, or 20 feet in length.
4. Completed applications must be submitted with sketch and cash/check or money order made payable to Mantua Township.  
Fee for Residential Permit **\$25.00**, Fee for Non-Residential Permit **\$50.00**
5. Once the completed application, sketch and fee are received the Code Enforcement Officer will issue a permit not to exceed 30 days as indicated on the approved permit.
